<i>Q:</i> A question was asked about the risk of falling reserves, given rise in staff costs.
A: Matt explained that the budget assumed an increase in giving, based on the increased numbers joining St Stephen's.
Q: Another question was asked about the Church of England pension fund which historically had not performed well (in a context of rising energy
costs, etc.) A: This would be investigated and closely monitored. Staff salaries had risen 2½% in line with inflation.
Vote: To re-appoint our auditors (MGI Midgley Snelling LLP). Proposed: Matt Baird
<b>Seconded:</b> Paul Sulma All in agreement to appoint the above auditors.
Reflection on 2021
Rachel described some of the highlights of the past year including the church picnic, Christmas in person, welcoming newcomers, especially families from Hong Kong.
The church was now holding five services including a midweek reflection. The 6pm service especially had been reinvigorated, boosted by regular socials. Children's activities included a successful Holiday Club. Seniors' activities were also thriving with a return to Monday Lunches and the successful <i>By Still Waters</i> service.
There had been a fresh approach to prayer with successful and well- attended <i>Kingdom Come</i> and <i>Worship Unplugged</i> events.
Under the vision of <i>growing disciples,</i> Rachel cast vision for at least 5 new life groups this year.
Looking forward, there were plans for a new teaching series on sharing faith. As Youth Pastor, Josh was booked to share the St Stephen's youth model with other youth leaders.
Under <i>Transforming Communities,</i> Fiona Smith was leading the response to the refugee crisis. The church was also developing a network of those involved in fostering and adoption. Yvette Dixon was re-launching the Richmond Sunday Lunches initiative with the first one planned for June.
St Stephen's continued its aspiration to be a <i>resourcing church</i> . Caroline Montgomery shared her vision for replicating the <i>Refresh</i> model with other churches. This included writing a book incorporating suggested material.
Mike Wilkinson thanked staff members for all their hard work.

The APCM meeting concluded with a closing blessing at 21:30. PCC members reconvened. Office holders were confirmed as follows: Colin Matthews – Chair; Matt Baird – Treasurer; FAB Chair; Sarah Gough – M&M Chair; Jen McCole – P&S Chair; Standing Committee comprised Committee Chairs, Brenda Begg, Jez, Rachel and Nicola Patel as a non-voting member. Nicola Patel – PCC Secretary with admin support from Caroline Perry. Colin outlined the ethos of the PCC and explained the work of the Committees.
